Finance Department – Implementation of Universal Social Security Pension- Modifying the eligibility conditions for Social Security Pensions and for the receipt of Welfare Fund Board Pensions as addition to the Social Security Pensions - Orders issued.

ORDER

Government provides Social Security Pensions on a monthly basis to the beneficiaries. Government have also introduced of a mechanism for the disbursement of Social Security Pensions as Home Delivery based on the decision of the Council of Ministers. Meanwhile Government in its order read as 2nd paper above have enhanced the minimum rate of Social Security Pension to Rs.1000/- per month from June 2016 onwards.

2. Based on the survey conducted by the Kudumbashree, as per Government order read as 3rd paper above. Home Delivery of Social Security Pensions to the beneficiaries through the District Co-operative Banks (DCB) / Primary Agricultural Credit Societies (PACS)/ Other Credit Co-operatives has been implemented vide GO read as 4th paper above.

3. The feedback from the Home delivery of Social Security Pensions and further discussion with the stake holders, Government decided to streamline the Social Security Pension and Welfare pension from Welfare Fund Boards.

4. Government after having examined the matter in detail and are pleased to issue the following orders/ guidelines for the eligibility for Social Security Pensions and the

conditions for receiving Pension from Welfare Fund Boards along with Social Security Pensions.

- a. All pensioners / applicants under Social Security Pension scheme should submit a self attested statement (Proforma attached) to the Panchayat Secretary to the effect that they are not in receipt of any Service pension or EPF pension , not paying Income Tax and are not having more than two acres of land in their name or for the family.
- b. Aadhaar details also should be given along with the above statement.
- c. A random verification will be done by Government.
- d. Self attested statement including Aadhaar details must be submitted to the LGs on or before 20/11/2016 by the beneficiaries.
- e. Cut of date for the payment of first pension must be the date of validation of each case by the DBT cell.
- f. Beneficiaries who are physically and mentally challenged are also eligible for any one of the Social Security Pensions without any reduction of rate.
- g. In cases where excess payment of pension has been made, further payment of pension will be effected only after adjusting the excess amount already paid.
- h. LGs should complete the mapping of pensioners based on the latest delimitation of ward by 20/11/2016
- i. Primary Agricultural Credit Societies (PACS) / Other Credit Co-operatives (OCC) should complete the mapping of pensioners based on the jurisdiction of the Society by 30/11/2016.
- j. PACS / OCC should record any payments made beyond their jurisdiction in the login facility provided to them.
- k. Those pensioners getting widow pension, in order to continue availing it, has to furnish in the month of December every year, a self attested certificate to the

Panchayat Secretary to the effect that the pensioner has not got re-married in the mean while.

- l. Those pensioners getting pension through Banks/ e money order should do the mustering through Akshaya centers in December every year
- m. All LGs are permitted to take the service of Kudumbashree workers for the collection of details from the beneficiaries , related data entry and verification of Aadhar details.
- n. Kudumbashree workers can use the same ID and password used for the purpose of survey for login.
- o. Expenditure in connection with the above may be met by the LGs from their own fund.
- p. Secretaries of LGs should validate the data keyed in by the Kudumbashree workers.

5. The Government Orders 2nd and 4th papers read above stand modified to the above extent.
