### ORDER

As per the Government Order read as 1<sup>st</sup> paper above, Shri.K.Premachandran, Municipal Secretary was granted Leave Without Allowances on medical certificate w.e.f. 18.5.2011 to 7.9.2011 with permission to suffix holidays from 8.9.2011 to 11.9.2011. Based on the fitness certificate Shri.K.Premachandran had rejoined duty as Secretary, Varkala Municipality on 12.9.2011. Considering the request of the Chairman, Varkala Municipality, the full additional charge of the post of Secretary was given to the Superintendent Shri.Jaya Kumar as per Order No.E2-14576/11 dated 3.10.2011 and same was ratified by the Government as per the the Government Order read as 2<sup>nd</sup> paper above. Shri.K.Premachandran had been posted as Secretary, South Paravur Municipality as per the Government Order read as 3<sup>rd</sup> paper above.

2. Shri.K.Premachandran has requested to regularise the period of waiting for posting from 4.10.2011 to 7.11.2011 and hence as per the Government Order read as 4<sup>th</sup> paper above, Shri.K.Premachandran was granted 35 days Earned Leave w.e.f. 4.10.2011 to 7.11.2011 for regularising the period of waiting for posting.

3. Shri.K.Premachandran had submitted appeal petition, as per the letter read as 5<sup>th</sup> paper above, for reconsidering the decision made as per the above mentioned Government Order and to treat the period as duty.

4. Government have examined the matter in detail. The period of waiting for posting of an officer starts with effect from the date on which he physically reported in Head Quarters for posting. Shri.K.Premachandran had relieved of his charges on 3.10.2011 and had sent an E-mail dated 12.10.2011 for further posting. Since Shri.K.Premachandran has not reported physically for duty in Head Quarters after he got relieved of his charges on 03.10.2011, the period cannot be regularised as duty.

5. Hence, the appeal petition, read as 5<sup>th</sup> paper above, submitted by Shri.K.Premachandran is rejected and orders accordingly.
