ORDER

As per Government Order read as 1st paper above the tenure of the Project of KLGSDP has been extended up to 30.06.2017 for the utilization of savings approximately to the tune of Rs.400 Crores due to dollar/Rupee fluctuation and other factors. The works regarding KLGSDP are to be implemented in a phased manner so that the targets can be within the stipulated time limit of the closure of the project. As per the minutes read as 2nd paper above, the Co-Ordination Committee have decided to submit the proposal for enhancement of remuneration of staff in KLGSDP to Government for consideration and approval. The Project Director, KLGSDP has submitted an enhancement proposal as per the letter read 3rd above.

2. Government examined the matter in detail and are pleased to enhance the remuneration (Monthly Consolidated Pay) of the staff appointed as contract basis with effect from December 2016 as detailed below.
