ORDER

The Commissioner for Rural Development, vide his letter read above, has forwarded an application from Sri.P.K.Appukuttan, Block Panchayat Secretary, Adimaly, Idukki for Interest Free Medical Advance amounting to ₹1,58,000/- (Rupees One lakh fifty eight thousand only) for his cardiac treatment at Bharat Cardio Vascular Institute, Kottayam. The Commissioner for Rural Development has recommended the application favourably.

2) Government have examined the matter in detail and are pleased to sanction an amount of ₹1,58,000/- (Rupees One lakh fifty eight thousand only) as Interest Free Medical Advance to Shri.P.K.Appukuttan, Block Panchayat Secretary, Adimaly, Idukki for his cardiac treatment at Bharat Cardio Vascular Institute, Kottayam, subject to the conditions specified in GO(P) No.45/97/H&FWD dated 18.02.1997, GO(P) No.285/2000/H&FWD dated 02.11.2000 and GO (P) No.298/2001/H&FWD dated 20.11.2001. The Utilization Certificate duly countersigned by the Medical Officer of the institution should be produced within 3 months from the date of drawal and the advance should be settled within 6 months. In case of default, penal interest @ 12% will be charged. Necessary entries should be made in the Service Book of the loanee regarding Interest Free Medical Advance with amount, number and date of the Government order, Contingent Bill Number and date of drawal of the loan. In case of Non drawal/ cancellation of Interest Free Medical Advance, the said fact should be reported to Government without fail. The date of encashment is to be

intimated to the Finance (Loans) Department in Government. Unutilized amount, if any, should be refunded immediately.

3) The expenditure on this account will be met from the Head of Account "7610-00-800-95-(01) - IFMA to Gazetted Officers" in the financial year 2016-17.
