**ORDER**

As per letter read as 1<sup>st</sup> paper above the Ministry of Drinking Water and Sanitation, Government of India, has released an amount of Rs.41,24,20,000/- towards first installment of Grant in Aid during 2016-2017 for the implementation of Swachh Bharat Mission (Gramin).

2) The Executive Director, Suchitwa Mission has requested Government to accord sanction to release the central share of Rs. 41,24,20,000/- and the corresponding state share with permission to the Commissioner for Rural Development to draw and transfer credit the amount to the Special TSB Account No.99 of Executive Director, Suchitwa Mission at District Treasury , Thiruvananthapuram.

3) As per GO read as 3<sup>rd</sup> paper above Govt. have authorised additional expenditure to the tune of Rs.63,75,61,000/- to accommodate the central release received and to provide corresponding state share under General, SCP and TSP components for SBM (G) for the year 2016-17.

4) Government have examined the matter and are pleased to release an amount of Rs.63,75,61,000/- (Rupees, Sixty Three Crore Seventy Five Lakh and Sixty One Thousand only), additionally authorised as per GO read as 3<sup>rd</sup> paper above, and the balance amounts of Rs. 298.85 lakh and Rs.199.22 lakh available under the heads of account “ 2515-00-101-65-(01)-(PV) ” and

“2515-00-101-65-(02) -(PV) ” respectively with permission to the Commissioner for Rural Development to draw and transfer credit the amount to the Special TSB Account No.99 of the Executive Director, Suchitwa Mission at District Treasury Thiruvananthapuram.


