As per order read as 1st paper above, Government set up a Local Government Commission to guide Decentralisation process in Kerala. 2. One Senior Professional having experience and expertise in matters relating to Local Level Planning and Decentralization and Democratization as Member.
3. Additional Chief Secretary/Principal Secretary/Secretary Local Self Government Department as the Member Secretary.

4) In the above circumstance Government are pleased to order to appoint Dr.N.Ramakanthan as the Member of the Commission. It is also ordered that Dr.C.P.Vinod will continue as the Chairman of the Commission.
