**ORDER**

The Director of Urban Affairs, in his letter read above, has submitted the proposal for the Establishment of Modern Slaughter House in eight urban local bodies at an amount of Rs.1000 lakh (Rupees Thousand lakh Only) .

In the Green Book introduced as a part of 2016-17 Annual Budget, **Rs.1000 lakh(Rupees Thousand lakh Only)** has been provided for establishing Modern Slaughter Houses in 8 various Urban Local Bodies each of cost Rs.1.25 crore.

Government have examined the matter in detail and are pleased to issue Administrative Sanction for an amount of **Rs.1000 Lakh(Rupees Thousand lakh Only)**for the Establishment of Modern Slaughter House in eight various urban local bodies each of cost Rs.1.25 crore by debiting the expenditure to the head of account "2217-80-192-91" in the current year's budget provision, subject to the following conditions:

- I) The Slaughter House proposed to be established should comply with all statutory provisions applicable and should have proper facilities.
- II) In addition to Government assistance, the concerned urban local bodies will find additional resources for the completion of the project.
- III) Tender/e-tender and other stipulated formalities shall be followed wherever necessary.
- IV) Store Purchase Rules shall be strictly adhered to
- V) The fund released will be based on actual requirement and receiving the utilization of amount if any already released. Fund released will not be allowed to be parked in banks.

- VI Post creation and purchase of vehicles are not admissible under the scheme.
- VII) The Director of Urban Affairs and urban local body concerned will be accountable for functional performance of the project once implemented
- VIII) The local government concerned will also ensure that ban on illegal slaughter if any shall be strictly enforced.
