ORDER

As per the Government Orders read above, Government have re-organized the Block Panchayaths in the State, inter alia created 6(Six) Block Panchayaths in the State with effect from 01-11-2010. Out of the 6 newly formed Block Panchayaths, Five of them have land for the construction of Office building. Construction of building for Block Panchayath, Parappa has almost completed and it is in the finishing stage.

2. As per the letter read above, the Commissioner for Rural Development has informed that an amount of Rs. 3,00,00,000/- (Rupees Three crore only) has been earmarked in the budget for the Financial year 2016-17 with the objective of constructing buildings for the newly created block panchayaths as part of the reorganisation of block panchayaths in the state as on 01-11-2010 and has submitted a detailed proposal requesting to accord administrative sanction for incurring expenditure from the above provision for completion of works of buildings of Parappa, Panamaram & Karadukka block panchayaths where the constructions are at various stages.

3. Government have examined the proposal and are pleased to accord administrative sanction for the project 'Construction of Buildings for newly formed Blocks' for an amount of ` 3,00,00,000/- (Rupees three crore only) subject to the condition that revised Technical Sanction incorporating unit cost, implementation schedule and other details shall be obtained. The expenditure shall be debited to the head of account '2515-00-197-36(01)-Construction of Building for newly formed Blocks and shall be incurred after following the due process as laid down.
