**ORDER**

As per G.O. read as 1<sup>st</sup> paper above, administrative sanction was accorded to Suchitwa Mission with an estimated cost of Rs. 60 Lakh under the Head of Account 22 17-05- 192-78 for engaging KITCO as Transaction Advisor for establishing Waste to Energy plant for Solid Waste Management at Brahmapuram, Kochi.

Vide G.O. read as 2<sup>nd</sup> paper and 3<sup>rd</sup> paper above government have accorded sanction for the release of first two installments of payments of transaction fee to KITCO in four installments. The executive Director Suchitwa Mission vide letter read as 4<sup>th</sup> paper above informed that M/s. KITCO has requested to release an amount of Rs.20,61,000/- towards the 3<sup>rd</sup> installment of the consultancy fee in respect of the work.

3. Government have examined the matter in detail and are pleased to accord sanction to Suchitwa Mission to meet 3<sup>rd</sup> instalment, 30% of the transaction fee of Rs.20,61,000 for KITCO as advisor for establishing waste

to Energy plant for waste management at Brahmapuram, Kochi from the amount available with Suchithwa Mission under the H/A - 2217-80-800-71(PV) during 2016-17.


