ORDER

As per the Government Order read 1st above deputation was initially granted for a period of one year to Sri. E.P. Rajamohan, Deputy Secretary to Government, Finance Department as Secretary, District Panchayat, Kasaragod. As per the Government Order read 2nd above the period of deputation was further extended for a period of one year from 02.03.2016. But subsequently as per the Government Order read as 3rd above the extension of deputation sanctioned as per the Government Order read 2nd above was cancelled and Sri. Rajamohan was directed to report back to his parent department with immediate effect. Now, the President, District Panchayat, Kasaragod as per the letter read as 4th paper above has requested to review the Government Order read 3rd above and to allow Sri. Rajamohan to continue in the post of Secretary, District Panchayat, Kasaragod.

Government have examined the matter in detail. The period of deputation sanctioned as per the Government Order read 2nd above expired on 01.03.2017. Government observe that for better implementation of the plan at the fag end of the financial year, the service of a Secretary in the District Panchayat is highly necessary. In the circumstances, the Government Order read 3rd above is superseded and the period of deputation in respect of Sri. E.P. Rajamohan, Deputy Secretary, Finance Department as Secretary, District Panchayat, Kasaragod is extended further for the period from 02.03.2017 to 31.03.2017.
