As proposed by Sri.Thiruvanchoor Radhakrishnan, MLA representing Kottayam Constituency under LAC-ADS for the year 2016-17, the Chief Engineer, PWD, Roads & Bridges, Thiruvananthapuram has furnished detailed estimate of the work Improvements to Kuzhimattom -Pallikadavu - Koombady road in Panachikkad Grama Panchayath at an estimate cost of Rs.31,00,000/- (Rupees Thirty one Lakh only) as per the reference read as 3rd paper above to accord Administrative Sanction and Special Sanction.

2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work Improvements to Kuzhimattom -Pallikadavu - Koombady road in Panachikkad Grama Panchayath proposed under LAC-ADS of Sri. Thiruvanchoor Radhakrishnan, MLA representing Kottayam Constituency for the year 2016-17, at an estimate cost of Rs 29.25 lakh (excluding service tax) with Special Sanction to take up the work for execution as deposit work through PWD subject to the resolution passed by the concerned Local Bodies in this regard,

following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government orders. The Chief Engineer, LSGD should take necessary action to deposit the required amount to PWD, the executing agency, as envisaged in the Circular read above.
