ORDER

Kerala Government Contractor's Federation, District Committee, Pathanamthitta represented by its Secretary, Shri.K.R. Krishnakumar filed WP(C) 35891/16 before the Hon'ble High Court with a plea to consider tendering of works below Rs.5 Lakhs under LSGD. The Hon'ble High Court in its judgement read above directed the 3rd respondent (The Convenor, State Decentralization Co-ordination Committee) to take a decision on Exbt. P7 representation after affording an opportunity of personal hearing to the petitioner within a period of 2 months from the date of receipt of the judgment. The Petitioner vide Exbt. P7 has requested to consider tendering of works below Rs. 5 Lakhs under LSGD. As per the letter read above, the Chief Engineer, LSGD has furnished a factual report based on the judgment & Exbt. P7 representation.

2) As directed in the judgment dated 9/11/2016, a personal hearing with the petitioner was conducted and also the Exbt. P7 representation was placed in the Co-ordination Committee held on 15/3/2017.

3) Government have examined the matter in detail and decided to consider the suggestions put forward by the Kerala Government Contractor's Federation in Exbt.P7 representation, while preparing the guidelines for Annual Plan 2017-18. The judgment read above is complied with accordingly.
