As proposed by **Sri.K.S.Sabarinathan, MLA representing Aruvikkara Constituency** under LAC-ADS for the year 2016-17, the Chief Engineer, Local Self Government Department, Thiruvananthapuram has furnished detailed estimate of 12 road works at a total estimate cost of **Rs.2,24,50,000/- (Rupees Two Crores Twenty four Lac and fifty Thousand only)** as per the reference read as 3rd paper above to accord Administrative Sanction.

2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the following 8 road works proposed under LAC-ADS of **Sri.K.S.Sabarinathan, MLA representing Aruvikkara Constituency** for the year 2016-17 at a total estimate cost of **Rs.1,37,50,000/- (Rupees One Crore Thirty Seven Lakh and Fifty Thousand only)** with Special Sanction to take up the works for execution, following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government orders.
