Ramesh Chennithala, Leader of Opposition and MLA representing Haripad Constituency, the Chief Engineer, Public Works Department(R&B), Thiruvananthapuram, as per letter read as 3rd paper above has furnished detailed estimates of the 15 works under LAC-ADS for the year 2016-17 at a total estimate cost of Rs.339,00,000/- (Rupees Three Crore Thirty Nine Lakhs Lac only) to accord Administrative Sanction and Special Sanction.

2).Government have examined the matter in detail and are pleased to accord Administrative Sanction for the following works proposed under LAC-ADS of Sri.Ramesh Chennithala, Leader of Opposition and MLA representing Haripad Constituency for the year 2016-17 at a total estimate cost of Rs.74,00,000/- (Rupees Seventy Four Lakh only) with Special Sanction to take up the works for execution as deposit work through PWD, following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government orders subject to resolution passed by the concerned Local Bodies in this regard. deposit the required amount to PWD, the executing agency, as envisaged in the circular read above.
