**ORDER**

As per order read as second paper above sanction was accorded for Construction of office building for Government Transport & Equipment Organization, Muvattupuzha. Since the estimate prepared for the purpose was in 2014, the Commissioner, Rural Development Department read as 3<sup>st</sup> paper above had submitted revised estimate for the same project for an amount of Rs 41,54,000/-.

2. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the revised estimate for the amount of Rs. 41,54,000/- (Rupees Forty One Lakhs Fifty Four Thousand only) for the purpose of construction of new building for Government Transport & Equipment Organization on the condition that technical sanction shall be issued by the competent authority in compliance of the following conditions

- i. The provisions of RCC in volume metric proportion of 1:1.5:3 and 1:2:4 for structural members shall be substituted with design concrete mixes of grade M20 and M15 with minimum cement content as stipulated in CPWD specifications.
- ii. Thickness of roof and floor slabs @15cm is on higher side and provision made for steel reinforcement in the estimate @100kg/m<sup>3</sup> for footings, columns, beams and slabs need to be optimized by design by competent and approved agency.
- iii. Lump sum provision @ Rs. 1,50,000/- is given for electrification. Detailed estimates shall be prepared while issuing the Technical Sanction.

The expenditure shall be met from the head of account '4515-00-103-98-16(P)'
