As proposed by Smt.Geetha Gopi, MLA representing Nattika Constituency as per the letter read as 2nd paper above, the Chief Engineer, PWD (Roads & Bridges), Thiruvananthapuram. has furnished detailed estimate of the work Construction of Thanyam thottanchira -Azhimaavu road of Thannyam Grama Panchayat under LAC-ADS for the year 2016-17 at an estimate cost of Rs.37,00,000/- (Rupees Thirty Seven Lakhs only) as per the reference read as 3rd paper above to accord Administrative Sanction.

2)Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work Construction of Thanyam thottanchira -Azhimaavu road of Thannyam Grama Panchayat under LAC-ADS of Smt.Geetha Gopi, MLA representing Nattika Constituency for the year 2016-17 at an estimate cost of Rs.37,00,000/- (Rupees Thirty Seven Lakhs only) following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government orders subject to the condition that the


