ORDER

The Chief Town Planner in his letter read as 4th paper above has forwarded the application of Sri.Samuel Thomas and Smt.Reena Samuel, Sharon, Kotheth Nagar, Kollam for regularising the unauthorised construction carried out in the land comprised in Resurvey No.99 of Kollam East Village in Kollam Corporation and recommended for regularising the unauthorised construction as per the Government Order read as first paper above.

2) Government have examined the application in exercise of the powers conferred under Rule 5(6) of the Kerala Municipality Building (Regularisation of Unauthorised Construction) Rules, 2014 and are pleased to accord sanction to the Secretary, Kollam Corporation to regularise the unauthorised construction of double storied residential building with a built up area of 108.206 Sq.metre constructed in a plot of extent 104 Sq.metre bearing Resurvey No.99 of Kollam East Village in Kollam Corporation is recommended for regularisation after collecting a compounding fee of Rs.4,469/- (Rupees Four thousand four hundred and sixty nine only).

3) The applicant should remit the compounding fee in the Government Treasury under the Head of Account "0217 Urban Development – 60 other Urban Development Schemes – 800 other receipts – 91 Compounding fee for regularisation of unauthorised construction violating provisions of building rules" within a period of 30 days from the date of this order and the chalan receipt in original should be produced before the Secretary, Kollam Corporation. The Secretary, Kollam Corporation in turn will take further action for regularisation as per Kerala Municipality Building (Regularisation of Unauthorised Construction) Rules, 2014.
