Government orders. The Chief Engineer, Local Self Government Department should take necessary action to deposit the required amount to PWD as envisaged in the Circular read above.


3) The expenditure in this regard shall be debited to the Head of Account '4515-00-800-96-Projects under LAC-ADS(NP)'.
