ORDER

Government of India as per letter read as 2nd paper above, have released an amount of Rs.44,47,77,000 (Rupees Forty Four Crore Forty Seven Lakh and Seventy Seven Thousand only) to the State Government of Kerala as Central Assistance towards the cost of material and administrative components for the implementation of MGNREGA for the financial year 2017-18 liquidating the pending liability of material components for the financial year 2016-17.

2. As per note read as 3rd paper above the Finance Department has informed that an amount of Rs.4447.77 Lakhs has been released by GOI and the same has been credited to State Govt.account and requested to release both central & matching state share of MGNREGS to implementing agencies .

Government have examined the matter in detail and are pleased to authorise the Commissioner for Rural Development to transfer credit an amount of Rs. 44,47,77,000 (Rupees Forty Four Crore Forty Seven Lakh and Seventy Seven Thousand only) being the 1st instalment of Central Assistance towards the cost of material and administrative components for the implementation of MGNREGA for the financial year 2017-18 and an amount of Rs.22,64,62,000(Rupees Twenty Two Crore Sixty Four Lakh and Sixty Two Thousand only) as the corresponding state share for 2017-18 and the pending liabilities for the financial year 2016-17 to the state level implementing agency as detailed below:
