2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work Construction of Side wall and steps at Kuttorkadavu in Vamanapuram Grama Panchayat under LAC-ADS of Adv. D.K.Murali, MLA representing Vamanapuram Constituency for the year 2016-17 at a total estimate cost of Rs.14,15,104/ (Rupees Fourteen Lakhs Fifteen Thousand One hundred and four, only) excluding the service tax of Rs. 84,895.97 from Rs. 15 Lakhs with Special Sanction to take up the works for execution, following all departmental
